## FEE MENU

INITIAL CONSULTATIONS: We offer 1-Hour consultations for a prepaid rate of \$300.

HOURLY FEES: We bill the following hourly rates for all retained clients:

| Attorney Rate | $\$ 250 / \mathrm{hr}$. |

| Paralegal/Law Clerk | $\$ 150 / \mathrm{hr}$. |
| Secretarial Tasks | Not Billable |

Rates may increase for Emergency Requests needing attention within 72-hours.

FLAT FEES: Flat fees are always available for transactions and often offered to you as a way to cut costs. Please see the Flat Fee Menu below for more details and information.

CONTINGENCY FEES: From time to time we offer contingency fees. If your case qualifies, you will be informed. Contingency plans offer a lower hourly rate in exchange for a percentage of the damages, but only if we win.

CASE INITIATION COSTS: The following nonrefundable payments are required to file a lawsuit in each respective Court. This payment covers all filing fees, service of process, and any other fees charged by the Court to initiate the case. These are not FLAT FEES.

## RETAINERS

RETAINER PLANS: The following refundable retainer deposits are due in order to open and maintain a case. Depending on the type of case you have, you will be required to have a minimum set retainer. You can always upgrade your retainer plan beyond the minimum requirement and save on flat fees.

NOTE: When reviewing these options, please keep in mind that Flat Fee Discounts do not apply to case initiation costs and/or initial consultation fees as these are not considered Flat Fees. Please also note that Flat Fees and additional discounts will be offered from time to time, regardless of what option you choose.

HYBRID/ CONTINGENCY OPTIONS: In some cases, you may be offered a discounted hourly rate in exchange for a share of the money we collect at the end of the case. If applied, the hourly rate will likely be $\$ 150 / \mathrm{hr}$. and the share will be up to $50 \%$ of judgment, minus funds already paid. If this option is available to you, you can always transfer your case from The Retainer Option to The Hybrid Contingency Option, however, you cannot do the reverse.
